### SUPERVISOR COMMENTS

The shift started out not being very busy, but quickly changed as the night continued. Officers were busy responding to several assaults, suicidal subjects, and traffic stops for DWI. Officers started the shift by dealing with a suicidal male. TPD received a call from his wife, stating tat her husband had a firearm and was threatening to shoot himself. Numerous officers arrived and began a dialog with both the caller and the husband. The officers were able to have both of them exit the residence, and the male was detained. A handgun was taken for safekeeping and the male was placed on a mental health hold. Officers also detained another subject on a mental health hold after she was seen trying to run into the path of vehicles on a roadway. Later, officers responded to a possible domestic violence situation. When officer arrived, they heard a loud argument coming form the residence. They contacted both the involved parties, and the male was arrested for domestic violence after they discovered injuries on the wife.

### SUPERVISOR COMMENTS

Several officers responded to the fairgrounds to assist CHP officers and Sheriff deputies on a call. The call was received as a male was holding two females hostage at gunpoint inside a trailer residence. It was determined that no crime actually occurred, and the male suspect had only made threats to kill himself. The male was reported to have a gun, but was alone on his property. Due to the circumstances, the decision was made to walk away from the call. SCU officers made a traffic stop on a vehicle that resulted in a probation search. During the search one of the passengers was found in possession of Xanax pills and anabolic steroids; He was arrested. Another officer arrested a male for outstanding warrants. While at the jail, the male was searched by deputies and was found to be hiding methamphetamine in his socks. He was charged with additional crimes and booked.
